THE REQUIREMENTS PARTICIPANTS NEED TO ADHERE TO

Contractors that wish to participate in this public tender must submit amongst others the following documentation when entering their bid:

1. A certified excerpt obtained through the business register of the Chamber of Commerce in Curaçao, which may not be older than 3 months;
2. A statement from the Tax Authority concerning the payment history of the company, which may not be older than 3 months;
3. A statement from the Social Insurance Bank, concerning the payment history of the company, which may not be older than 3 months;
4. A Certificate of Good Conduct, which may not be older than 6 months (as of yet the director of the corporation or those that in actuality lead the business need to hand-in the Certificate of Good Conduct);
5. A statement from the Common Court of Justice indicating that the corporation is not bankrupt, nor is a moratorium to be passed, nor going into liquidation, nor have any of the above been requested. This may be not older than 3 months.

The remaining requirements which the participants must adhere to, have been included in the bidding document and specification.
