REQUEST FOR NEW WATER CONNECTION

THE REQUIRED DOCUMENTS ARE:

- Filled application form for power/water supply
- Valid ID of property owner
- Proof of property ownership (Land Registry extract, purchase agreement, notary deed, or Chamber of Commerce extract)

REQUEST TO ACTIVATE EXISTING WATER, POWER CONNECTION

THE REQUIRED DOCUMENTS ARE:

- Filled application form for power/water supply
- Valid ID of property owner
- Proof of property ownership (Land Registry extract, purchase agreement, notary deed, or Chamber of Commerce extract)



REQUEST FOR PRODUCT CHANGE FROM CONVENTIONAL TO PREPAID OR SOLAR

THE REQUIRED DOCUMENTS ARE:

- Filled application form for power/water supply
- Valid ID of property owner



REQUEST FOR SERVICE TERMINATION

THE REQUIRED DOCUMENTS ARE:

- Filled form for termination of power/water supply
- Valid ID of property owner
- Picture showing the current position of the meter



REQUEST FOR PAYMENT AGREEMENT

THE REQUIRED DOCUMENTS ARE:

- Valid ID of the account holder



IMPORTANT

- Owner's authorization is necessary in case someone other than the property owner is submitting a service request for any of our services.
- Valid ID is an identification document (ID card, passport, or driver's license).
- An international ID might be accepted as a valid ID.
- Chamber of Commerce extract not older than three (3) months
- Indicate on a plan the preferred location of the water meter, if applicable.

REQUEST FOR PRODUCT CHANGE FROM CONVENTIONAL TO PREPAID OR SOLAR

THE REQUIRED DOCUMENTS ARE:

- Filled application form for power/water supply
- Valid ID of both the property owner and the petitioner
- Written consent of the property owner authorizing the product change



REQUIRED FOR SERVICE TERMINATION

THE REQUIRED DOCUMENTS ARE:

- Filled termination form for power/water supply
- Valid ID of both the property owner and the petitioner
- Lease contract
- For commercial clients, Chamber of Commerce extract
- Picture showing the current position of the meter



REQUEST FOR PAYMENT AGREEMENT

THE REQUIRED DOCUMENTS ARE:

- Valid ID of the account holder



IMPORTANT

- Valid ID is an identification document (ID card, passport, or driver's license).
- For individuals without a Dutch/American passport, a valid residency permit, or legal admission status ('toelating van rechtswege').
- Chamber of Commerce extract no older than three (3) months
- Indicate on a plan the location of the water meter if this applies to a specific meter.
